POVERTY HAS INCREASED BY 4% AND PER CAPITA INCOME FELL TO LEVELS OF OVER A DECADE AGO. ALMOST 3 MILLION ENTERPRISES, THE MAJORITY OF THEM SMALL BUSINESSES (SBS), ARE IN DANGER OF CLOSING, PUTTING 8.5 MILLION JOBS AT RISK. OUR PROPOSAL IS THEREFORE TO LEVERAGE THE LARGEST NETWORK OF ENTREPRENEURIAL SUPPORT ORGANIZATIONS (ESOS) IN THE LATIN AMERICAN ECOSYSTEM TO SUPPORT PURPOSE-DRIVEN SBS WITH THE POTENTIAL TO FUEL INCLUSIVE PROSPERITY ACROSS LATIN AMERICA.
